ORGANIZATION OF DISTRIBUTION OF FOOD, HYGIENE AND SANITATION ITEMS TO FAMILIES

AFFECTED BY COVID-19 LOCKDOWN IN MUHANGA DISTRICT

1-Background of the activities and rationale

Sustainable Development and Humanitarian Action (SDHA) as a local humanitarian NGO in partnership with its partners and volunteers wants to distribute some food, hygiene and sanitary items to families affected by COVID-19 pandemic lock-down and recent disasters of heavy rains as relief intervention to beneficiaries for coping with aftermath of those challenges. Due to this very reason, Muhanga district and Ministry of Emergency Management (MINEMA) sent a call for emergency support to which SDHA wishes to respond.

2- Activity location and selection criteria

Muhanga is one of the most affected district by disasters in Rwanda which effects were accrued by the national lock-down and social distancing. The selection criteria are as follow:

- 1. Families will be located in Muhanga district, in/or in one of the Makera watershed riparian sectors (Nyamabuye, Cyeza, Muhanga).
- 2. Poorest families in social Categories 1 or 2 of Ubudehe who are much effected by Covid-19 by lockdown
- 3. Families affected by both lockdown and disasters of heavy rains March-May 2020 (those who lost theirs and/or whose houses and assets destroyed)
- 4. Items are sticks of soaps, food (pulses, cereals, oil &sugar), face masks, Hygiene equipment (Basins& jugs)

3- Organizational modalities

In its interventions SDHA as humanitarian organization concurs with OCHA humanitarian principles namely Humanity-Neutrality-Impartiality and Independence. Therefore, the activities is organized as follow:

Basing on above criteria and in collaboration with JADF-Muhanga, beneficiaries will be selected by the local authorities who will submit the list to SDHA for consideration. Following principles will be observed.

- Families will receive equal/similar package of items
- SDHA will distribute items in presence and at the office of local authorities (cell or sector selected)
- Beneficiary-families will sign for reception of items for SDHA & Donors report purpose
- Activity will be organized one day and items be distributed once (at ago in one chosen place/site)
